I am Vice President Finance Nuclear for Exelon Generation, an applicant under the Zero Emission Certificate Application being submitted jointly by PSEG Nuclear, LLC ("PSEG Nuclear") and Exelon Generation for Salem Unit 2 nuclear power plant located in Lower Alloways Creek Township, Salem County, New Jersey ("Application");
